

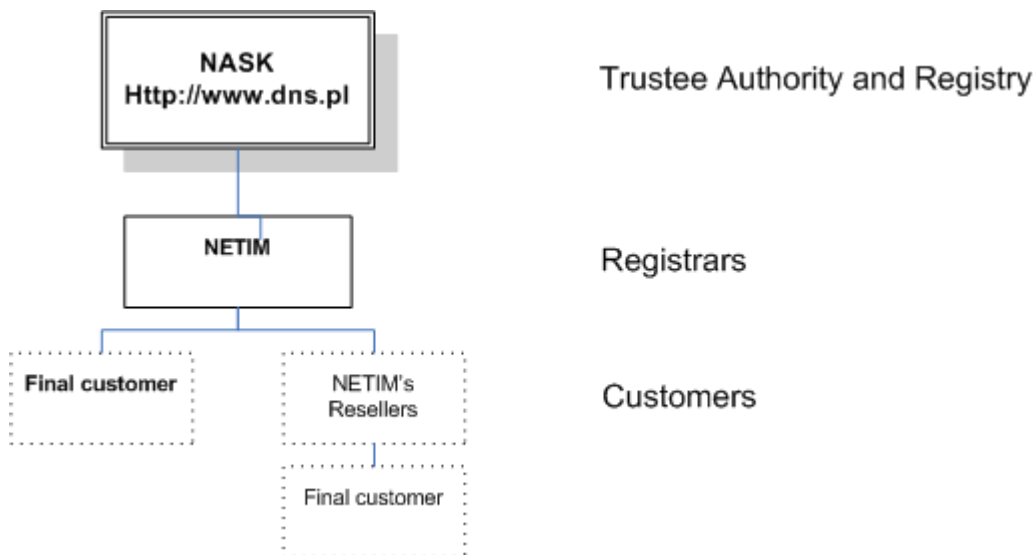
ANNEXE PL - SPECIAL TERMS AND CONDITIONS FOR THE ccTLD .PL

In addition to the general terms and conditions CG-ND, the registration or use of a Domain Name in a .PL Extension implies the acceptance and respect of these special terms and conditions CP-ND-PL.

All terms employed in these special terms and conditions beginning with a capital letter are to be interpreted in compliance with the definition assigned to them in the general terms and conditions CG-ND.

SECTION PL.1: TRUSTEE AUTHORITY AND REGISTRY

PL.1.1 The following diagram shows the different operators and the naming system for this Extension



PL.1.2 NETIM act as an accredited registrar for the management of .PL domain names.

SECTION PL.2: REGISTRATION REGULATIONS

PL.2.1 Domain Names under this Extension are registered on a "first come, first served" basis

PL.2.2 The Client declares and guarantees that the Domain Name respects the rights of third-parties, currently applicable laws as well as the regulations specific to the Extension, which can be consulted at the following addresses:

The Client agrees to have read and accepted this contractual document (the "PL Regulations" below) which links him to the Registry. These special terms and conditions do not substitute these regulations which are integrated by means of a hyperlink.

SECTION PL.3: TRANSFER REGULATIONS

PL.3.1 The Client initiates through the intermediary of NETIM a transfer request for a Domain Name in .PL from another registrar to NETIM (also referred to as "incoming transfer"), according to the procedure specified on our site, and in compliance with PL Regulations:

PL.3.2 The client must follow the described procedure and, particularly, must provide a valid authorization code to NETIM. Otherwise the transfer cannot be proceeded with and the Client may not claim any compensation or refund from NETIM

PL.3.3 The transfer to NETIM does not include any renewal for the Domain Name.

PL.3.4 In the context of a transfer of a Domain Name to another Registrar, the authorisation code can be

obtained in the Interface and are sent by electronic mail to the Client's email address.

SECTION PL.4: CHANGE of OWNERSHIP REGULATIONS

PL.4.1 The Client initiates, through the intermediary of NETIM, a request for a change of ownership for a Domain Name in .PL

PL.4.2 The change does not take effect immediately. The Client must provide the application form and the needed proof of identity to NETIM by the way of his choice. The application will be checked and approved by the sole discretion of NETIM.

PL.4.3 If the Client does not provide a correct application, the change cannot be proceeded with and the Client may not claim any compensation or refund from NETIM.

PL.4.4 The change of ownership does not include any renewal for the Domain Name.

SECTION PL.5: EXPIRY / RESTORATION REGULATIONS

PL.5.1 When the Domain Name's expiry date has passed without prior renewal by the Client, the Domain Name shall then be disabled for a period of fifteen (15) calendar days during which all NETIM's associated services shall no longer be available. The Domain Name shall be referred to as in "quarantine" status

PL.5.2 If a Domain Name has been disabled with the past fifteen (15) calendar days, it can be reactivated subject to the following conditions and procedures, and depending on the details provided to NETIM when carrying out these procedures:

- i) restoration is only possible from a technical point of view for the so-called "quarantine" period, which is the fifteen (15) day period defined above.
- ii) payment for the restoration must be made one (1) day before the destruction of the Domain Name by the Registry, to enable NETIM to carry out the operation within the time limit. Failing this, the Domain Name cannot be restored and NETIM cannot be held responsible on these grounds.
- iii) the restoration procedure restores the Domain Name's previous parameters (personal and technical information) and extends by one (1) year the duration of the Domain Name's registration starting from the previous expiry date.

SECTION PL.6: CONSENTS

The Client hereby grant to NETIM, who concluded Agreement with NASK (the Registry) on cooperation concerning internet domain names, **consent to perform any activities** with respect to the Research and Academic Computer Network – a research and development entity (hereinafter referred to as "NASK"), including legal activities concerning the management of Domain Names, including data regarding the registrant, in particular: Domain Name Registration, change of the Registrant, removal of the Domain Name, change of data concerning devices used for the Domain Name, as well as provision by NASK to the Registrar data processing and transmission concerning the Client intended for Maintenance of Domain Names.

SECTION PL.7: ADDITIONNAL SERVICES

NETIM doesn't provide the following services offered by the Registry:

- Waiting List service
- Domain Name Testing service

SECTION PL.8: CONTRACTUAL AMENDMENTS FOR SPECIAL TERMS AND CONDITIONS

Regulation laid down by the Trustee Authority and the Registry are subject to change. These changes, linked to the naming system for .PL extensions are imposed by NASK in charge of this Extension and represent changes that are not beyond NETIM's control.
