

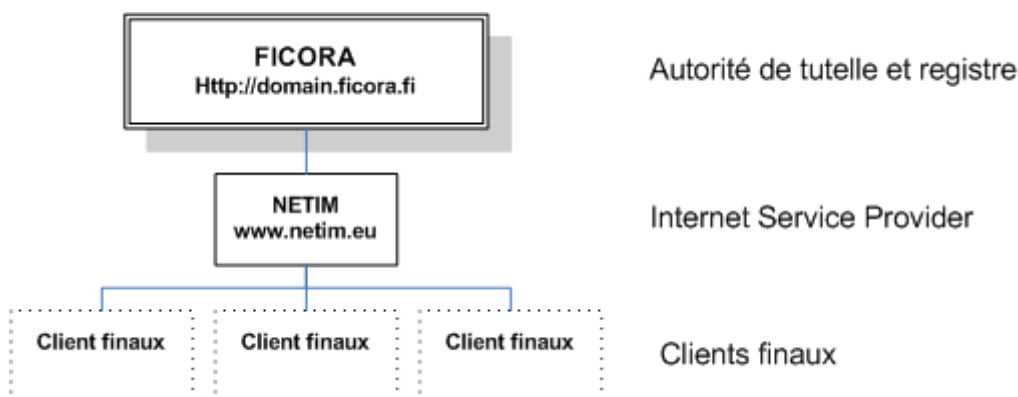
ANNEXE FI - SPECIAL TERMS AND CONDITIONS FOR THE ccTLD .FI

In addition to the general terms and conditions CG-ND, the registration or use of a Domain Name in a .FI Extension implies the acceptance and respect of these special terms and conditions CP-ND-FI.

All terms employed in these special terms and conditions beginning with a capital letter are to be interpreted in compliance with the definition assigned to them in the general terms and conditions CG-ND.

SECTION FI.1: TRUSTEE AUTHORITY AND REGISTRY

FI.1.1 The following diagram shows the different operators and the naming system for this Extension



FI.1.2 NETIM is act as an official ISP, accredited by Ficora, for the management of .FI domain names

SECTION FI.2: REGISTRATION REGULATIONS

FI.2.1 Domain Names under this Extension are registered on a "*first come, first served*" basis

FI.2.2 The Client declares and guarantees that the Domain Name respects the rights of third-parties, currently applicable laws as well as the regulations specific to the Extension, which can be consulted at the following addresses:

The Client agrees to have read and accepted this contractual document (the "FI Regulations" below) which links it to the Registry. These special terms and conditions do not substitute these regulations which are integrated by means of a hyperlink.

FI.2.3 All of the following people can register the .FI domain name of their choice, the owner (applicant) must be:

1. a person of at least 15 years of age who has a Finnish Personal Identity Number and is resident in Finland,
2. a legal entity, resident in Finland, like a company entered in the Finnish Trade Register, the Finnish Register of Associations or the Finnish Register of Foundations

ARTICLE FI.3 : SPECIAL REQUIEREMENTS

FI.3.1 Regarding FI Regulations, the administrative contact must reside in Finland.

F1.3.3 Regarding FI Regulations, the name servers (DNS) of the domain name must be correctly configured as specified in the Registry's technical specifications

SECTION FI.4: CONTRACTUAL AMENDMENTS FOR SPECIAL TERMS AND CONDITIONS
