

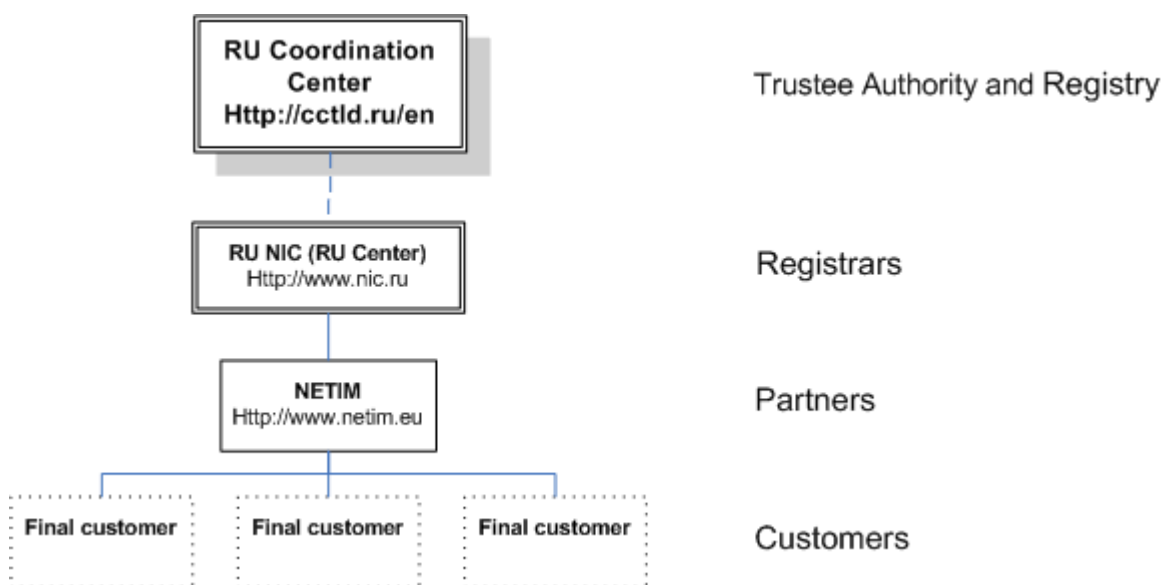
ANNEXE RU - SPECIAL TERMS AND CONDITIONS FOR THE ccTLD .RU

In addition to the general terms and conditions CG-ND, the registration or use of a Domain Name in a .RU Extension implies the acceptance and respect of these special terms and conditions CP-ND-RU.

All terms employed in these special terms and conditions beginning with a capital letter are to be interpreted in compliance with the definition assigned to them in the general terms and conditions CG-ND.

SECTION RU.1: TRUSTEE AUTHORITY AND REGISTRY

RU.1.1 The following diagram shows the different operators and the naming system for this Extension



RU.1.2 Because only russian companies can become accredited registrars of .RU, NETIM signed a partnership with RU-CENTER in order to provide, through an automated system, registrations and management of .RU domain names.

SECTION RU.2: REGISTRATION REGULATIONS

RU.2.1 Domain Names under this Extension are registered on a "*first come, first served*" basis

RU.2.2 The Client declares and guarantees that the Domain Name respects the rights of third-parties, currently applicable laws as well as the regulations specific to the Extension, which can be consulted at the following addresses:

The Client agrees to have read and accepted this contractual document (the "RU Regulations" below) which links it to the Registry. These special terms and conditions do not substitute these regulations which are integrated by means of a hyperlink.

RU.2.3 It is not required to perform the identification process in order to register a domain (see RU.3.1)

SECTION RU.3: SPECIAL REQUIREMENTS

RU.3.1 A registrant that owns a domain Names under this Extension can have two statuses: "Verified" / "Un verified". A registrant is verified once the identification process is successful.

RU.3.2 A registrant can be verified by sending identity proofs to RU-CENTER; for legal entities a copy of the certificate about state registration of a legal entity issued by the state authorities; for natural persons passport copy (personal details and issuance data); for entrepreneur passport copy (personal details and issuance data).

RU.3.3 The registrant can be contacted, at any time, by RU-CENTER for an identification request. The registrant must send them the proofs of identity within 3 days. Failure to do so will lead to the domain name deletion by RU-CENTER, without the right to claim any refund and without NETIM's liability being incurred,

RU.3.4 Identification documents can be sent at any time or on request to RU-CENTER:

Don't forget to provide them the **contract number of the registrant's handle**. You can get it into the webinterface NETIM direct section "Owner" into domain name's general information.

RU.3.5 Be aware that the following operation will not be possible if the registrant is not verified:

- change of registrant's data
- domain transfer to another Registrar
- domain transfer to another Registrant
- waive administration rights (registration cancellation).

SECTION RU.4: CONTRACTUAL AMENDMENTS FOR SPECIAL TERMS AND CONDITIONS

RU..1 Regulation laid down by the Trustee Authority and the Registry are subject to change. These changes, linked to the naming system for .RU extensions are imposed by the Registry in charge of this Extension and represent changes that are not beyond NETIM's control.
